1. CONDITIONS OF ENTRY

1.1 A boat is entirely responsible for her own safety, whether afloat or ashore, and nothing, whether in the Notice of Race or Sailing Instructions or anywhere else reduces this responsibility.

1.2 It is for the boat to decide whether she is fit to sail in the conditions in which she will find herself. By launching, the boat confirms that she is fit for those conditions and that her crew is competent to sail and compete in them.

1.3 The boat is required to hold adequate insurance and in particular to hold insurance against third party claims in the sum of at least £2m.

1.4 Nothing done by the organisers can reduce the responsibility of the boat nor will it make the organisers responsible for any loss, damage, death or personal injury, however it may have occurred, as a result of the boat taking part in the racing. The organisers encompass everyone helping to run the race and the event, and include the organising authority, the race committee, the race officer, patrol boats and beach masters.

1.5 The provision of patrol boats does not relieve the boat of her responsibilities.

1.6 The fact that the race committee may conduct inspections of a boat does not reduce the responsibilities of the boat set out in this paragraph.

1.7 The crew are required to sign the entry form and by doing so they will be entering into certain undertakings, warranties and indemnities which are set out there at length.
